

PRIVACY POLICY

This Privacy Policy supplements the Hector International Airport Website Terms of Use (collectively, this “Agreement”). We provide this Privacy Policy to make you aware of our privacy practices and the choices you can make about the way your information is collected and used.

The Website Terms of Use contain important provisions, including provisions disclaiming, limiting, or excluding the liability of Hector International Airport for your use of the Website and provisions determining the applicable law and exclusive jurisdiction for the resolution of any disputes regarding your use of the Website.

Securing personal information we collect from you is of great concern to us. We exercise care in providing secure transmission of your information from your computer to our servers in connection with the Hector International Airport Website.

Personal information collected by the Website is stored in secure operating environments that are not available to the public. While Hector International Airport has mechanisms in place to safeguard your personal information once we receive it, please remember no transmission of data over the Internet or any other public network can be guaranteed to be 100% secure.

WHAT WE COLLECT

In general, the types of personal information we collect may include, but are not limited to: your first and last name, email address, mailing address and information about your interest in Hector International Airport (for example, your profession).

SHARING OF INFORMATION

In general, we provide access to your personal information only to affiliates, agents, vendors or service providers, who help us to provide products or services to you, or otherwise perform functions on our behalf. We will not sell or otherwise transfer your data to a third party for monetary consideration. We may disclose information about you to a non-affiliated third party at your request or if you consent to the disclosure.

CHANGES AND ACCEPTANCE

Hector International Airport reserves the right, at its sole discretion, to change, modify, add or remove portions of this Agreement, at any time. You are advised to check the Privacy Policy from time to time for any updates or changes that may affect you, as this is a legal contract binding on you. Your continued use of the Website following the posting of changes will mean that you accept and agree to the changes. As long as you

comply with these Terms of Use, Hector International Airport grants you a personal, non-exclusive, non-transferable, limited privilege to enter and use the Website.

APPLICATION

This policy applies to the information you provide to Hector International Airport through the Website. This policy does not apply to information collected by third parties linked in any way to the Website. We have no control over, and no responsibility or liability for, any third party's collection, use, disclosure, or retention of the personal information that is provided directly to them, and that collection, use, disclosure, and retention is not subject to this policy.

INFORMATION AUTOMATICALLY COLLECTED

Hector International Airport automatically tracks certain information based on your behavior on our site. We use this information to analyze our users' behavior, interests, and demographics to better understand and serve you. This information may include websites or search engines that referred you to our site, what browser you are using, and your IP address.

USE OF INFORMATION

Hector International Airport may use information collected on the Hector International Airport Website, which may include information gathered about you, for various purposes. Hector International Airport uses personal information it collects to pursue our mission and operations, including the management of our Website and to engage in related activities. You should assume that we will use all information for all lawful purposes, including, without limitation, to provide you with information you request, to allow users to interact with social networks and platforms, and to enable Hector International Airport to monitor and analyze web traffic.

We do not purport to have listed all possible disclosures that we might make. This Privacy Policy is intended to help you understand our general practices. This Privacy Policy is not a promise that your information will never be disclosed except as described above.

We generally will retain information for as long as required, allowed, or for as long as we believe it useful. If you cease using the Website, or your permission to use the Website is terminated, we may continue to use and disclose your personal information in accordance with this Policy as amended from time to time. We do not undertake retention obligations through this Privacy Policy. We may dispose of information in our discretion without notice, subject to applicable law. Secure, confidential information will be disposed of accordingly.

COOKIES

We may place a "cookie" on the browser of your computer. Cookies are small pieces of information that a website will store on your computer's hard drive to identify you during

your session and make Hector International Airport services easier to use. Cookies are never used to store sensitive customer information such as names, addresses, credit card numbers or passwords. Acceptance of cookies is not a requirement to browse our site. Most browsers automatically accept cookies, but you can configure your browser to prevent that.

OTHER WEBSITES

Our website and publications contain numerous links to other websites. We cannot be responsible for the privacy practices of other organizations or the content of external websites.

MESSAGES FROM HECTOR INTERNATIONAL AIRPORT

Subscribers to information provided by Hector International Airport are given the opportunity to opt-in or opt-out of receiving periodic messages. You may discontinue the delivery of news and updates at any time. If you do not wish to receive certain communications from us, you may opt out by:
